Monitoring Confirmation

President's Report

President Boys asked those in attendance to join him in observing a moment of silence in memory of Bill Horne. He thanked those involved in making Bill's memorial a meaningful and fitting service.

President Boys highlighted some of the areas in his written report as follows.

• Strategic Vision Planning. Trustees were encouraged to visit the strategic vision communication web page that has been created. It includes a video of the all-college meeting where Dr. Boys

spoke to faculty and staff about the vision, an interactive blog and a brief survey with questions about involvement.

- January Retreat/Meeting. The dates of January 23-24 have been selected for the retreat/meeting.
- *Lindsey Wilson Partnership*. Congratulations were expressed to the nine students who will graduate with a master's degree from Lindsey Wilson College through its partnership with Southern State Community College.
- *Student Success*. Trustees were asked, if they haven't already, to review the information provided in the President's written report on Tutoring and Disability Services.

In addition, President Boys announced Southern State Community College, in conjunction with the Highland County Chamber of Commerce, will hold a quarterly meeting (Coffee and Commerce) with legislators, which will provide opportunity to interface with the business community. President Boys will inform Trustees when the meetings are scheduled.

President Boys reported he attended SSCC's annual high school counselor program at Fayette Campus earlier today. The purpose of the program is to provide a College update to area counselors. Of the 23 high schools in SSCC's district, 18 were represented. Appreciation was expressed to Lisa Copas, Director of Recruitment, for coordinating the program.

President Boys informed the Board that the Ohio Association of Community Colleges is preparing a proposal to present to Governor Elect Kasich related to the next biennium budget. Individuals involved in working on the proposal from the state's 23 community colleges include four trustees, of which Chairwoman Ayres is one, and four presidents.

A question was raised on the Emergency Medical Program section of the President's written report. Dr. Boys assured the Board the program is accredited and steps have been taken to address the areas of concern.

President Boys introduced Kathe Chaney and Karee Shaw, Site Administrators of the Southern State Community College Patri-Tots Learning Centers. They provided a historical overview of the PTLC, a snapshot of a child's day at the center and spoke about the positive influence the PTLC has on the lives of the children it serves.

Vice President of Business and Finance Report

Vice President of Business and Finance Jim Buck directed the Board's attention to a bound copy of the Fiscal Year 2010 Audited Financial Report provided in the Board Packet and noted it contains an unqualified opinion. He stated the auditors also reviewed the Financial Aid records and the Foundation records in addition to the College Financial records. Dr. Boys added there was no management letter and applauded the work of the Business and Financial Aid offices for such a clean audit.

Consideration of FY 2011 Revised Budget

Vice President of Business and Finance Jim Buck proposed a revised budget for FY 2011, which, he noted, reflects an increase of eight-tenths of 1 percent. He explained an adjustment for a reduced state funding and increased enrollment make up the eight-tenths of 1 percent. Trustee Moore moved and Trustee Cimis seconded the Board approve the following Revised Budget for FY 2011:

In an effort to connect Trustees to their home counties and to give them opportunities to promote the college, Trustees will be kept informed of Southern State programs in their local high schools.

Board Policy Manual Committee Report

Vice Chairwoman Wilson reported the Board Policy Manual Committee, comprised of Trustees Ayres, Popp and Wilson, with President Boys' support, is working to update the Board Policy Manual. She stated the current rules and regulations, including duties of the Board of Trustees, were adopted in 1974,

and reviewed the status of previous updates that had not been adopted. President Boys has prepared an updated draft of the Policy Manual dated September 28, 2010. The Committee seeks to present to the Board of Trustees a revised manual that meets the following goals:

- Updates the functions and responsibilities of the Board to match current practice,
- States the functions and responsibilities in ways that are straightforward, focused, defensible and actionable,
- Builds on the good work of Board members who compiled the earlier documents as well as the draft prepared by President Boys, and
- Complies with the rules and regulations of the Office of the Attorney General.

The committee plans to share and discuss this work with the Trustees at the retreat in January.
