Adoption of SQRP and 415(m) Plan and Amendment to the Alternative Retirement Plan

Vice Chair Moore moved and Trustee Boedeker seconded the following Resolutions be adopted.

Adoption of SQRP and 415(m) Plan.

WHEREAS, the Internal Revenue Code of 1986, as amended (the "Code"), imposes certain limits on contributions that may be made to various qualified retirement plans, including the State Teachers Retirement System ("STRS"), the Ohio Public Employees Retirement System ("OPERS"), the Alternative Retirement Plan, and 403(b) plans (collectively the "Retirement Plans"); and

WHEREAS, the Code also permits Southern State Community College (the "College") as a governmental employer to adopt a Supplemental Qualified Retirement Plan (the "SQRP")

and a Supplemental 415(m) Retirement Plan (the "415(m) Plan") that will permit the College's Board of Trustees (the "Board") to make discretionary retirement contributions on behalf of designated College employees; and

WHEREAS, the College, in its employment agreement with its president, has promised to provide its president with deferred compensation contributions of \$20,000 a year for five years to an annuity contract, with the intent being that such contributions would be made pursuant to and administered in accordance with an SQRP and 415(m) Plan; and

WHEREAS, the Board believes that it is in the best interest of the College to adopt an SQRP and 415(m) Plan.

NOW, THEREFORE, the Board of Trustees does resolve as follows:

- 1. That the College hereby adopts the Southern State Community College Supplemental Qualified Retirement Plan and 415(m) Plan in substantially the form attached hereto and as may be amended with the advice of counsel.
- 2. That the appropriate officers of the College are hereby authorized and empowered to make any changes to the SQRP and 415(m) Plan as may be required to ensure compliance with the provisions of the Code, the Ohio Revised Code, and any related rules and regulations now in effect or as hereafter amended.
- 3. That the appropriate officers of the College are directed to take such action as may be necessary, appropriate, or advisable to implement this Resolution without further ratification or action by this Board.

Amendment to the Alternative Retirement Plan

WHEREAS, the Board of Trustees originally adopted the Southern State Community College Chapter 3305 Alternative Retirement Plan (the "ARP"), as amended and restated from time to time; and

WHEREAS, the Employer has the ability to amend the ARP from time to time; and

WHEREAS, the Employer desires to amend the ARP to make certain changes in accordance with applicable law.

NOW, THEREFORE, the Board of Trustees resolves as follows:

- 1. That the amendment to the ARP, in substantially the form attached hereto, be and hereby is adopted effective as stated therein; and
- 2. That the Director of Human Resources is hereby authorized to execute the amendment to

the ARP and any other agreements, certificates, instruments, documents, or conveyances necessary to effectuate the amendment to the ARP.
