President's Report

President Boys highlighted a few items in his report, beginning with the busy legislative season. He explained that the Capital Bill has passed the House and Senate, and has been signed by Governor Kasich. The \$1.25 million for an Adams County Campus was approved, as well as the \$16 million small campus pool. Chancellor Carey will soon be making the selection of distribution of that \$16 million. President Boys passed around to the Board a copy of SSCC's proposal, including letters of support, adding that he recently testified in front of both the House and the Senate, with no resistance on the small campus pool from either audience. President Boys encouraged the Board to be thinking about their own personal preferences and considering the land option scenarios, as once a selection is made, they will need to act quickly for a possible groundbreaking as early as Fall 2014.

President Boys also mentioned the positive opportunities and ventures through the partnership with Sinclair Community College, as well as congratulated Dr. J.R. Roush on presenting his dissertation before the American Educational Research Association, a scholarly association for educational research.
