#### **Meetings on Capitol Hill**

While in Washington, D.C. for the fall AACC commissions and board meeting, I met with staff from Senator Brown's and Portman's offices to discuss continued funding of the POWER grants that are administered by the Appalachian Regional Commission. As described on the ARC website, the POWER Initiative (Partnerships for Opportunity and Workforce and Economic Revitalization) is a multi-agency, congressionally funded initiative that targets federal resources to help communities and regions that have been affected by job losses in coal mining, coal power plant operations, and coal-related supply chain industries due to the changing economics of America's energy production. With the impending closure of coal-fired electricity production plants in Adams County, we would anticipate applying for one of these competitive grants for our Adams County Campus once the federal budget is approved. Both the House and Senate have included a provision for the POWER initiative in their budget proposals.

#### **Dual Enrollment Meetings at the State and National Level**

I was honored to participate in a joint meeting of the American Association of Community Colleges and the American Association of School Administrators (the nation's superintendent association) for a convening of best practices in dual enrollment and efforts to better prepare our nation's young people for college readiness. Although the enrollment in our dual enrollment population is among the highest of those attending the convening, I heard several presentations on specific initiatives to target more of the technical pathways to meet the talent pipeline.

State-wide, course enrollment has largely been in general education area. Tom Walsh, Vice President of the OACC, and I represented the state's community colleges at two stakeholder sessions with the Ohio Department of Higher Education to provide feedback related to rules regarding course eligibility and underperforming students. We advocated, in the clearest terms, the case for not placing barriers upon students who have an interest in pursuing technical

certificates and degrees in order to meet current workforce needs. Our concerted efforts in career services and guided pathways will provide good structures for assisting more students in choosing and completing technical education.

#### **2017 Trustees Conference**

Trustee Stevens and I attended the annual trustee's conference sponsored by the Ohio Department of Higher Education at Columbus State Community College. Major topics included a review of efficiency and affordability efforts, fiduciary expectations and accountability, institutional risk management, and how higher education is defining and investing in outcomes and attainment. # **ACADEMIC AFFAIRS**

#### **Report on Duplicate Programs**

A compliance measure stemming from Section 3345.35 of the Ohio Revised Code and subsequently, the Governor's Task Force on Affordability and Efficiency, requires that

the board of trustees of each state instituiton should consider program consolidations where possible. Particular attention was directed to co-located campuses. In response to this directive, Southern State has reviewed the programs identified as "duplicative" and analyzed them with regard to quantitative and qualitative parameters defined by ODHE, the College's existing program review system, as well as an emerging framework for program vitality. Among these factors include enrollments, graduation rates, faculty resources, market demand, centrality to the College's mission and reputation, etc. This report is included for your review and includes a proposed resolution for consideration.

#### **Accreditation**

On Nov. 30, the College will submit a required monitoring report on assessment, retention, persistence, and completion. This report outlines the College's responsiveness to feedback from the 2015 comprehensive visit in which the team noted a lack of evidence that the College effectively used assessment of student learning data to make improvements. Additionally, the team noted a similar deficiency in data-informed decision making in regard to retention, persistence, and completion. The institutional response is grounded on a new approach to institutional effectiveness and several strategic investments including the institutional research function and participation in the HLC Assessment Academy.

# **Grant Updates**

#### **Innovation Grant**

Rio Grande and Shawnee State joined together with Southern State to apply for the ODHE Innovation Grant Program. The grant is designed to promote educational excellence and economic efficiency throughout the state in order to stabilize or reduce tuition rates at institutions of higher education. The total grant award was \$1 million and Southern State received \$207,200 towards an innovative advising model and career readiness. The career readiness is designed to connect students at the high school to college resources as well as the importance of saving time and money by identifying

pathways early.

#### **RAPIDS**

As a part of the Regionally Aligned Priorities in Delivering Skills (RAPIDS), Southern State and the Southeast Consortium, has been presented to the controlling board for approval. This grant allows SSCC to purchase equipment for industrial manufacturing. The total consortium grant for the region was \$1 million with Southern State receiving \$124,000. Other partners include Hocking College, Shawnee State University, Rio Grande, and Ohio University.

### **Presentations and Recognition**

#### **Workforce Education Conference**

The National Conference of Workforce Education met in Salt Lake City, Utah on Oct. 25 and Oct. 26. Jeff Montgomery, John Joy, Shawn Tomlin, and Amy McClellan presented at the National Conference discussing the value of partnerships in rural areas.

#### **National Partnership for Education Access**

A presentation proposal submitted by Dr. JR Roush has been accepted by the National Partnership for Educational Access (NPEA). This Conference, *Standing Together in a Changing Landscape: A Call to Action*, taking will take place on April 11-13, 2018. Dr. Roush will be presenting with colleagues from Morehead State University and focusing on the importance of exposing students to resources they can use as they make the transition from middle school to high school to college and/or the workforce, and beyond.

# Workforce Development, Truck Driving Academy, and Continuing Education

- Ohio Department of Public Safety audited the TDA student records and other compliance related items on Oct. 3, with no significant violations identified.
- On Oct. 19, John Joy and John Smith met with Dr. Craig Klein, the new Dean of Community College Planning at Rio Grande to discuss joint CDL training at the Jackson location. Based on the meeting, the partnership is expected to be sustained.
- On Nov. 3, John Joy met with leadership of the Paint Creek Joint EMS/Fire District to discuss leadership and team building training to be completed in January or February of 2018. Group members are finalizing the training content.
- Customized training was provided in October and November to NCB Bank of Hillsboro
  as well as to Valero Energy Renewables of Washington C. H. The training for both
  focused on Microsoft Office software.
- Training began in early November with G & J Pepsi Cola of Franklin Furnace, Ohio to start contract instructional training for incumbent workers. Training began in Columbus with the first group of those employees on Nov. 13. The instruction will be on Pepsi Cola sites throughout southern and eastern Ohio, using their equipment and facilities. Pepsi is phasing out this training internally with plans to continue contracting it out. The training could extend into most of 2018.
- On Nov. 14, John Joy met with the Clinton County Auditor's office team to discuss Excel training for the auditor's staff. Pending the Commissioners' approval, the training will be offered in early January or February.
- STNA training began on Nov. 14 at Central Campus with 12 students enrolled.
- On Nov. 15, John Joy and John Smith met with Frank Barker of Great Oaks to discuss supplying contracted instructional training in dump truck operations to support their heavy equipment training programs at Laurel Oaks campus in Wilmington, and at Scarlet Oaks campus in Sharonville.

• \$25,000 of the third round of ODHE's Revolving Loan Funds have been granted to TDA students, who otherwise could not afford the short-term training in what is still, more than ever, a high-demand occupation.

#### **Disabilities Services**

#### **Ohio Ahead State Conference**

The Disabilities Coordinator attended Ohio Ahead State Conference at Miami University on Oct. 13. Sessions of interest included: Supporting Students with Autism Spectrum Disorder (ASD): What you can do Now!, Evidence-based Interventions for Individuals with Developmental Disabilities and Co-occurring Mental Health Disorders, and The Productivity Circle – Collaborative Work to Empower Students with ADHD.

#### **Mindfulness in Counseling Workshop**

The Disabilities Coordinator attended a Mindfulness in Counseling workshop at Xavier University on Oct. 6 and Nov. 3. Topics of interest included: self-care, mindfulness, meditation, and yoga.

#### **Financial Aid**

**Year-Round Pell** 

Pell grants are being added for all Pell-eligible students for the upcoming Summer semester who attended during the Fall semester.

All eligible students will receive updated award information on the opportunity to receive the year-round Pell grant, if they attend half-time.

#### **MASFAA Conference**

On Oct. 9, Linda Myers presented at the Midwest Association of Student Financial Aid Administrator's conference at the University of Dayton, with Camielle Headlam from MDRC on the EASE project. The session was titled **Making Summer Pay Off: Using Behavioral Science to Encourage Additional Summer Enrollment.** Southern State was chosen to present insight on the implementation lessons related to the first phase of the project. The project currently includes 10 community colleges throughout the State of Ohio.

#### **Financial Aid Outreach**

Financial aid nights or senior class presentations were conducted at Hillsboro High School, Georgetown, Wilmington, Eastern Brown, Madison Plains and East Clinton to assist students and families with the financial aid filing process for the upcoming academic year.

Students receive phone calls and emails from academic advisors regarding their academic status and are provided with resources or faculty communication for getting back on track with their academics.

Letters with support contact information are sent to students with mid semester grades of D/F in the effort to get them back on track.

#### **Academic and Career Advising**

Advisors have assisted 505 students in the first nine weeks of the term. Advisors also provide students career advising and pathway alignment for career/academic goals as part of their sessions.

Preparation for the Spring registration process is underway as the Student Success Center hopes to see most of the returning student registered before Thanksgiving break.

#### **Tutoring Services**

The creation of Online Standardized Test Prep tutorials will aid students in their preparation for Accuplacer, TEAS/HESI (allied health program entrance exams), and ACT/SAT.

Guided workshops are being offered to assist students with hands-on preparation.

#### **Veterans Services**

Robert Hixson participated in the US Army Concurrent Admissions Program training (college-focused program encouraging new military recruits to begin college career while enlisted) at DeVry University in Cincinnati, sponsored by the Columbus Recruiting Battalion.

Bob also presented at Faculty Senate on the unique circumstances when advising veteran students.

#### **Career and Counseling**

#### Suicide Prevention Training

The Career & Counseling Services Coordinator completed 15 hours of training in Suicide Treatment sponsored by the Ohio Suicide Prevention Foundation -- a part of the HB 28 suicide prevention initiative. Training involved focusing on the suicidal behavior, thoughts, and feelings in a collaborative manner with the client in order to decrease and eliminate suicidal thoughts and behaviors.

#### Class Presentations

Presentations in College English Courses – composition and business/technical writing – focused on the beginning process of resume and cover letter writing, as well as the

proper use of resumes.

Career and Counseling Services provides workshops in various development areas as an alternative to cancelling classes when faculty are unable to meet for a class session. Topics include resume development, interviewing etiquette, suicide prevention, and bystander intervention for sexual assault.

#### High School Presentations

Presentations were given at Miami Trace High School Junior Achievement Classes last month on business and professional communication (listening) and job interviewing.
